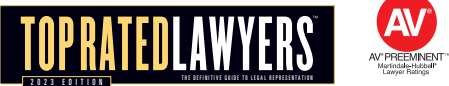

PROFESSIONAL LIABILITY AND COMMERCIAL LITIGATION – FORT LAUDERDALE, FLORIDA

David Keller is passionate about defending the reputations of lawyers and law firms. He is frequently engaged to represent some of the largest firms in the country and often defends “bet-the-law-firm” cases. Most recently he won summary judgment in July 2023 on a \$14 million claim against an Am Law 100 firm. Some of his other recent cases include five significant trials within seven months, four of which he took over from other counsel after years of litigation — he prevailed in four, and settled a fifth one favorably for his client after 8 days of trial. In the five trials, claimants were seeking in excess of \$37 million, plus substantial punitive damages against a major law firm in one case. Keller’s clients recovered substantial fees and costs in several of the cases on which he prevailed. He won two Jury Verdicts, and prevailed on a Directed Verdict after taking over the defense of one case less than a month before trial. In one of the cases, after five days of trial, he won a dismissal of claims, and complete relief on a counterclaim, with the court reserving jurisdiction to award fees, costs, and sanctions after exposing the case as a fraud on the court. But relatively few cases end up in trial, and Keller is equally effective in winning dispositive motions, handling arbitration and mediations, and evaluating and resolving cases quickly and quietly when appropriate, often without formal mediation or arbitration. Keller also frequently represents lawyers in Florida Bar Grievance and disciplinary proceedings.

Mr. Keller served on the Seventeenth Circuit Judicial Nominating Commission from 2011-2018, and on JNC for the Fourth District Court of Appeal from 2018 until 2022. Mr. Keller has been elected to membership in the Federation of Defense & Corporate Counsel, and the American Board of Trial Advocates, and maintains membership in the Defense Research Institute, and the Florida Defense Lawyers Association. He was named Trial Attorney of the Year for 2016 by the Fort Lauderdale Chapter of the American Board of Trial Advocates and was recognized by the Broward County Bar Association in June 2023 with the Lynn Futch Professionalism Award. He served in the American Bar Association House of Delegates from 1990-1992 and 2002-2006 and has served the Florida Bar and local bar associations in various capacities, including as President of the Fort Lauderdale Chapter of ABOTA (2009), President of the Broward County Bar Young Lawyers Section, President of the Broward County Federal Bar Association (1997-1998), Chairman of a local Grievance Committee, member of The Florida Bar Young Lawyers Division Board of Governors, and on The Florida Bar Civil Rules Committee. He has also served as a member of the Board of Directors of The Harmonie Group, a national affiliation of leading commercial defense firms.

Mr. Keller is an AV Preeminent[®] rated lawyer with Martindale-Hubbell[®]. 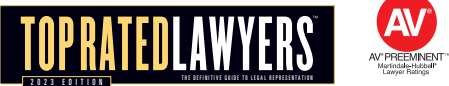

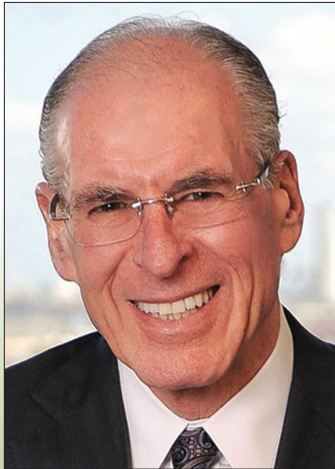
